## Tessera raises Q3 revenue guidance

**Tessera Technologies Inc.** on Thursday raised its third quarter revenue guidance to between \$65 million and \$66 million.

San Jose-based Tessera (NASDAQ:TSRA) had provided earlier guidance of \$60 million to \$62 million in revenue.

The company also raised its micro-electronics revenue, all of which will be royalty and license related, to between \$58 million and \$59 million. Tessera's earlier guidance was for \$54 million to \$56 million.

The company said it had improved second quarter performance in its served markets.
